LOOP 202 SOUTH MOUNTAIN FREEWAY NOISE MEASUREMENT LEVELS | MARCH 2-6, 2020

Following the opening of the Loop 202 South Mountain Freeway in December 2019, the Arizona Department of Transportation received a number of requests from residents of the adjacent communities for noise-level measurements. The primary purpose of the measurements was to establish the noise levels along the entire corridor, at locations and times requested by the residents (during morning and evening rush hours). The noise measurements were taken between March 2 and March 6, 2020. The noise measurements were aligned with ongoing freeway constructions activities, prior to school spring break and an overlay of rubberized asphalt.

Additional testing of freeway noise levels is scheduled throughout the 22-mile corridor in summer 2020 when the freeway is fully operational, and then in compliance with the Record of Decision issued with the Final Environmental Impact Statement.

Results of the noise measurements at specific locations are provided in the table below, followed with spatially located visual representation of the results.
