Southern Arizona Paving & Construction Co. failed to acknowledge receipt of Addendum No. 1. Addendum No. 1 had no effect on the work for this project. It allowed the bidders the option of submitting their bids electronically. The State Engineer considers this irregularity to be waivable and recommends award to Southern Arizona Paving & Construction Co. The second low bidder, Granite Construction Company, filed a protest of the recommendation.

Not every irregularity results in mandatory rejection. Subsection 102.10 – Irregular Proposals established two types of irregularities. Paragraph (A) lists examples of irregularities that are waivable. Paragraph (B) lists those irregularities which are specifically not waivable. Failure to acknowledge receipt of addendum is not shown in Paragraph (B).

The work that Southern Arizona Paving & Construction proposed in their bid conforms in every respect with the bid requirements. The only thing Southern Arizona Paving & Construction didn't acknowledge was the opportunity to submit a bid electronically. The addendum had no possible effect on the work proposed to be performed, the price, or the quality or quantity of work. There was no advantage to the contractor due to failure to check receipt of the addendum. Finally, no bidders submitted bids electronically on this project.

Granite Construction has cited examples where the Board rejected bids due to failure to acknowledge addendum. In those examples, there was a possibility that the addendum not acknowledged could affect the work proposed to be performed, the price, or the quality or quantity of work. This possibility is not presented in this matter.
