**COMMENTS:**

**On August 17, 2009, Contractors West protested the potential award to Roadway Electric, claiming that Roadway Electric and all the other bidders did not submit a bid that meets the specification for Items 7310190 and 9240119.**

**At the Board meeting on September 18, 2009, the Board postponed action to allow all bidders the opportunity to submit a response to the Department by 5:00 pm September 25, 2009.**

**The Department received two letters. G.U.Y. Construction submitted a letter dated September 22, 2009 asking the Department to reject all bids.**

**The Department received a submittal from Roadway Electric on September 24, 2009. The submittal stated that Roadway Electric's bid was for poles that would meet the plans and specifications and that the specified poles would be furnished and installed. The submittal also contained structural calculations and shop drawings for the poles and foundations.**

**After review of the submittal by and with staff, the State Engineer concludes that the bid submitted by Roadway Electric meets the requirements of the advertised project. While the pole foundations may require modification, the State Engineer does not believe there will be a material change in the contract as a whole. Therefore, the State Engineer believes that the Roadway Electric bid satisfies the requirements of the advertised project and that Roadway Electric will be able to meet the requirements of the project.**

**Therefore, the State Engineer recommends award of the contract to Roadway Electric, LLC.**
