

**MINUTES OF THE
STATE TRANSPORTATION BOARD MEETING
10:30 a.m., Friday, January 21, 2005
City of Bullhead Council Chambers

The State Transportation Board met in official session for a Board meeting at 10:30 a.m., Friday, January 21, 2005, with Vice Chairman Rusty Gant presiding. Other Board members present included: Dick Hileman, Delbert Householder, Joe Lane, Jim Martin, new board member Bob Montoya and Si Schorr via phone. Also present were Director Victor Mendez; Dale Buskirk, Director, Planning Division; Mike Ortega, State Engineer; Barclay Dick, Division Director, Aeronautics Division; and John McGee, Chief Financial Officer, Administrative Services Division. There were approximately 75 people in the audience.

OPENING REMARKS AND PLEDGE

Vice Chairman Gant led the audience in the Pledge of Allegiance and thanked the City of Bullhead for their hospitality. Dignitaries in the audience were introduced.

DISTRICT ENGINEER REPORT

Sam Elters, District Engineer for Bullhead City provided an update on projects and issues of regional significance. The area boundaries were identified. Projects discussed included the Hoover Dam bypass and US93. The majority of the work on US93 has been on public land administered by the Bureau of Land Management. A feasibility study for Corridor 95 was completed through an IGA between the Bureau of Land Management and Mohave County and ADOT. The design concept phase is in progress. Bridge problems on SR95 are being addressed. SR95 South of Lake Havasu City entailed an aggressive public relations campaign. A proactive approach to access management is being taken particularly on US93 and SR95. Enhancement projects in the area were noted.

CALL TO THE AUDIENCE

Mike Conner, President, Bullhead Area Chamber of Commerce addressed the Highway 95 bypass project between Highway 68 and I-40. The ability to move traffic is a concern due to the overwhelming growth in the region. Laughlin Ranch will add 30 square miles to the city. Without proper planning, we will encounter infrastructure problems. Anticipated growth within fifteen years will bring the population to 100,000. Currently, more than five million people come to visit the Laughlin/Bullhead City area each year. There is one bridge connecting the two cities. Truck accidents close the bridge and all traffic must be re-routed. The City cannot wait for highway improvements.

Monica Gates, Mayor of Kingman, reported an increase of 54% in residential building permits in the past year. To encourage healthy growth in the area, connectivity is needed. Ms. Gates asked to include the Rattlesnake Wash interchange on the project plan.

Tommie Martin, Supervisor, Gila County thanked the Board for the emphasis placed in Gila County, particularly during the past ten years.

Kerry Ballard, Vice Mayor, Town of Snowflake, announced a new Town Manager, thanked Bill Jeffers and thanked members for their work on a project.

Paul Prechel, Councilmember, City of Coolidge, mentioned that a business under construction applied for a permit for a slow down turning lane and after about six months, started to inquiry about the status of the permit. He said the department lost it and appeared not to be in a hurry. Mr. Prechel asked that the process be expedited or a system developed to check progress as permits work their way through the department.

John Hudson, Greater Yuma Port Authority, thanked the Board for keeping the area service highway on track. A new port is opening. The federal permits from both sides of the border have been obtained for this most modern, state-of-the-art port on the United States border. Without ADOT's support for a road to connect the port with the interstate system, there wouldn't be a port.

Jim Palmer, Graham County Supervisor, expressed appreciation for work being done on Highway 191 both north and south; the progress is going well toward I-10. There are two gaps in the project that need to be programmed and Mr. Palmer asked for consideration in the near future. Programming for Highway 70 is encouraged as there is a new Phelps Dodge business under construction. A letter of support was sent for the Gold Canyon bypass, an important link for Graham County to travel to the Maricopa County area and the Gonzales Pass area would enhance transportation into Phoenix as well.

Ingo Radicke, Consultant, Gila County, discussed a project on Highway 60, a pavement project and widening project.

Dan Brown, City Councilor, City of Page, mentioned he attended Legislative Day and thanked ADOT for their work. Mr. Brown discussed the Page Rest Area Visitor Center. Last fall, the project was on track and Mr. Brown recently discovered the project may not be in the 2010 plan. This small project is important to the City and the City is willing to dedicate resources and asks for direction to get it done.

Casey Prochaska, Chairman, Yuma County Board of Supervisors, thanked members for their support and outreach.

Greg Stanley, Engineer for Pinal County, discussed the Gold Canyon bypass, it being in the corridor definition stage and the desire to get it into the construction program. It is an impediment to the flow of traffic, a congestion issue and safety concern. Several regional events occur each year causing traffic backups.

Tom Sockwell, Supervisor, Mohave County, discussed the Highway 95 realignment. Mohave County is mostly a maintenance organization without the funding or ability to build roads. He asked for help in getting the Highway realignment done.

Richard Young, Navajo County Engineer, expressed appreciation for the ADOT crew's rapid response and amount of help given to the recent levee failure.

Leigh Verley, Chairman/President, Bullhead Regional Economic Development Authority, supports the Highway 95 realignment.

CONSENT AGENDA

There were no items removed from the consent agenda.

Director's Report

Victor Mendez stated that a public transportation division was created last year and Mr. Jim Vickey was selected as division director. He comes from Valley Metro and will begin duties on February 1.

Testimonies before the House Transportation Committee and the Senate Transportation Committee consisted of an ADOT overview. ADOT's budget was presented to the Senate Appropriations Committee. The Governor's budget is a solid proposal. The legislative proposal is not as positive. Environmental compliance issues need to be addressed and have never been funded previously. Growth issues and other financial issues were addressed with legislators as well.

Financial Report

John McGee provided summary reports on revenue collections for Highway User Revenues and Maricopa Transportation Excise Tax Revenues, comparing fiscal year results to last year's actuals and forecasts, and reported on interest earnings, HELP Fund status, and other financial information relative to the Board and Department. December HURF collections totaled \$102.4 million, a decrease of 2.1 percent from December 2003 and 3.3 percent below the estimate. The month-to-month comparison is less meaningful as the December 2003 collections did not include fuel tax payments from two fuel suppliers that were processed in January 2004. Year-to-date collections total \$599.0 million, an increase of 7.2 percent over the same period last year and 1.0 percent above the estimate. All categories continue to show good growth. All except Vehicle License Tax are above the estimate. The November RARF collections were \$25.2 million, an increase of 7.2 percent above November 2003 and 0.5 percent above the estimate. Year-to-date collections total \$125.1 million, an increase of 8.4 percent over last year and 1.1 percent over the forecast. All categories are over last year and all except Retail Sales and Utilities are ahead of the estimate. The Investment Report during the month of November indicates earnings of \$1.546 million on investments for an average of 2.07 percent. The average return rate continues to climb. Year-to-date earnings stand at \$6.14 million for an average return of 1.92 percent. The HELP fund balance for the month of December is \$104.6 million, an increase of approximately \$5.3 million over last month. HURF forecasts included in the packet were discussed as well as RARF forecasts for 2004 to 2025.

Financing Program

John McGee reported that Representative Biggs, Chairman of the House Transportation Committee introduced HB2123 that would continue the Board's authority to execute more funding through the year 2020. The current authority ends in 2008 and without that extension, the board's HELP

program would be diminished over the next couple of years. The bill was heard in the House Transportation Committee and was unanimously approved. The Senate Transportation Committee seems to be receptive.

FY 2006 – 2010 Financial Update

John McGee presented a financial update on ADOT’s discretionary funding for the period FY 2006 – 2010. The analysis has been updated as well as revenue forecasts as noted earlier. For FY 2005-2009, total net funding increases by a small amount. For FY2010 net funding will increase by almost \$7 million. Based on this new information, it was indicated to the planning division that we can now program to a level of \$640 million for the year 2010.


