General Information

An MVR is a record of information issued by the Motor Vehicle Division pertaining to the driving status or history of a:

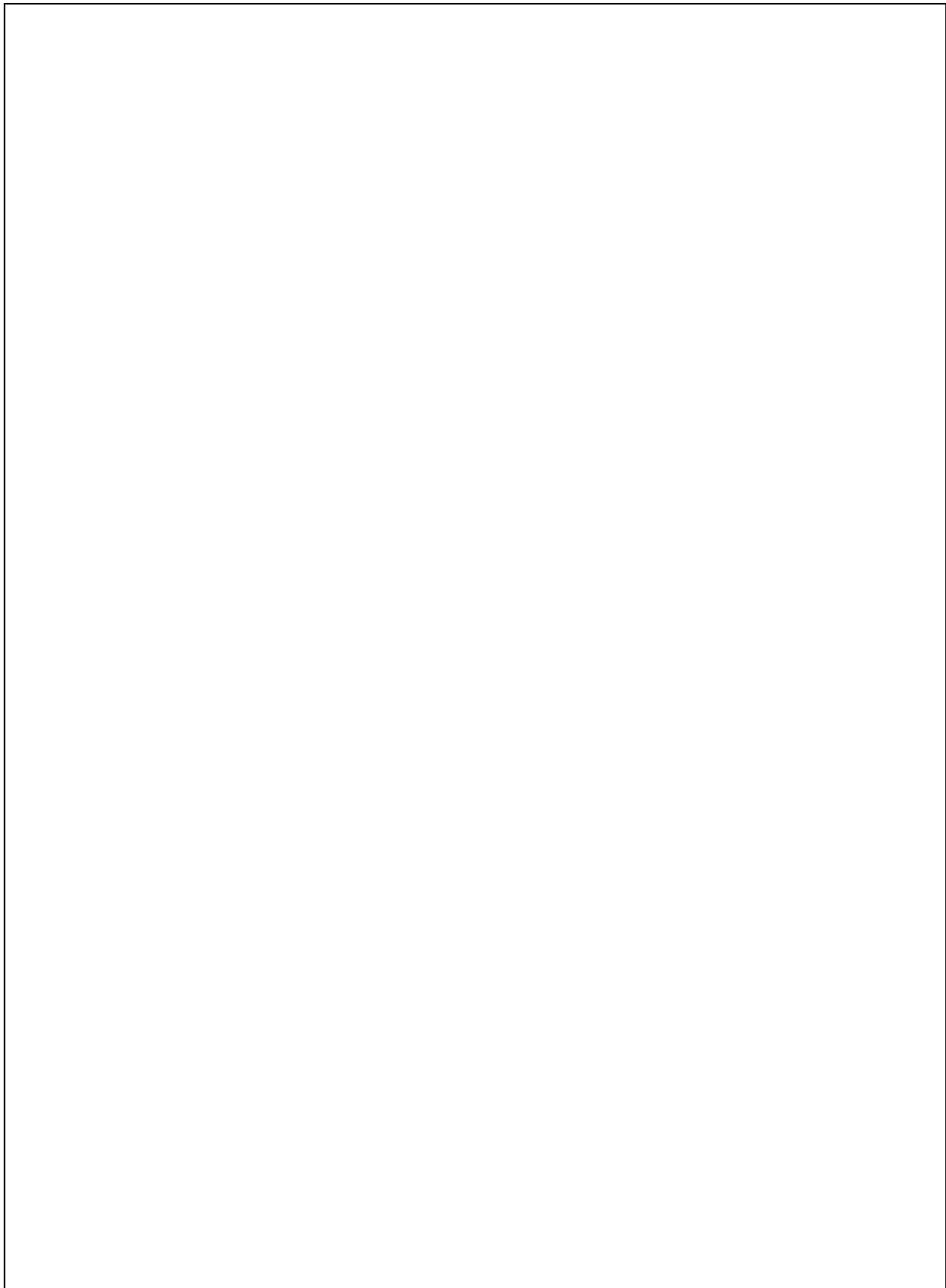
- Individuals driver license
- Commercial driver license
- Instruction permit
- Identification license
- Title
- Permit
- Lienholder

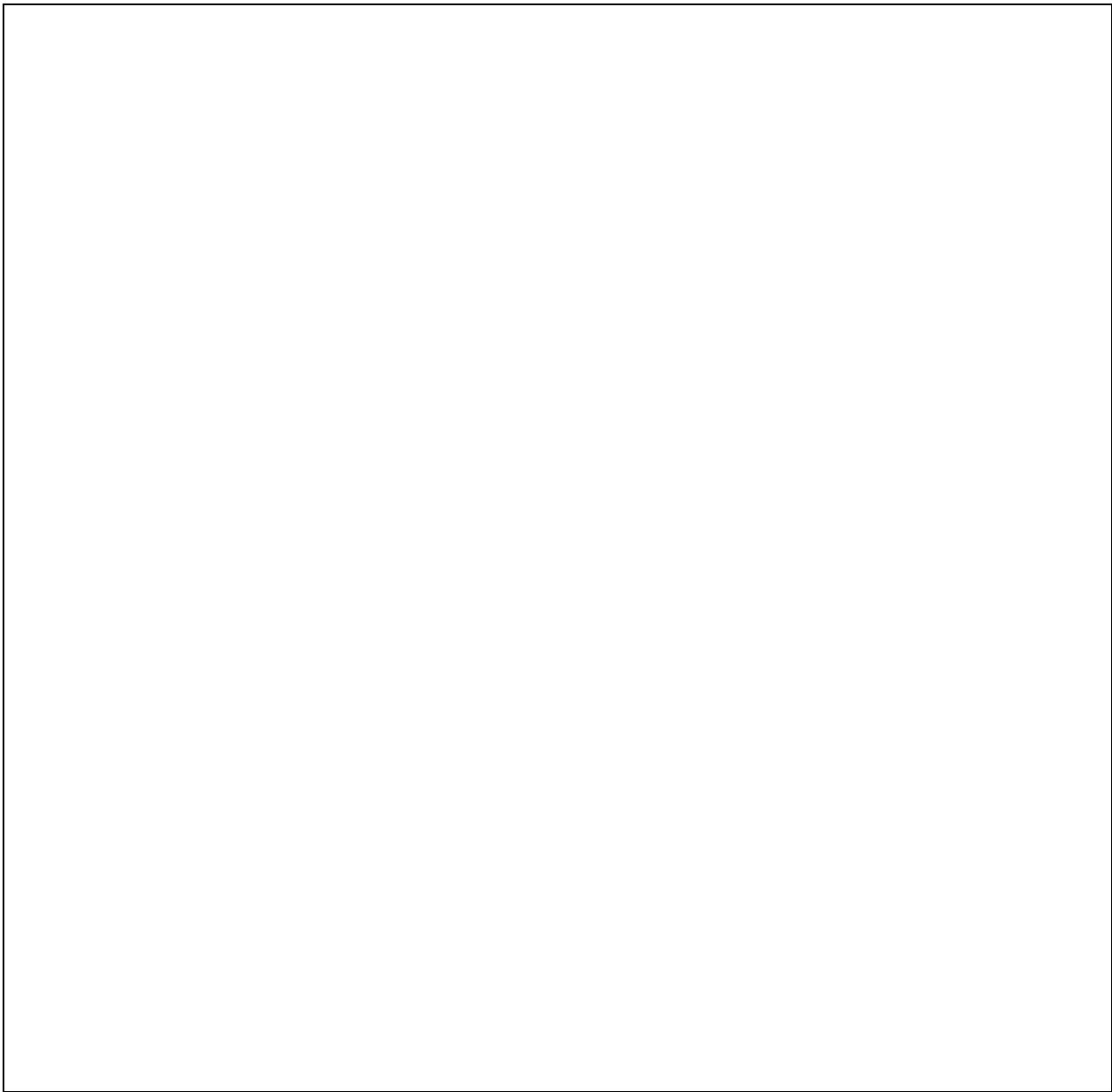
Courts requesting an MVR:

- It is the responsibility of the Court and any authorized user acting on their behalf, to gain knowledge of all laws and applicable MVD policies and procedures which govern access to and use of MVD records

A non-restricted ten year driver license MVR appears on the next two pages.

The MVR will be broken down into six sections and discussed in detail. On the following two pages is a sample of a two page MVR. The page following the sample, we will begin the breakdown of a 10 Year MVR.

Section 1:

This heading identifies the MVR being requested and also shows the date the request was made and agency code of the requestor. The document statement appears on each page of the MVR. On subsequent pages the driver's name replaces the type of MVR being requested.

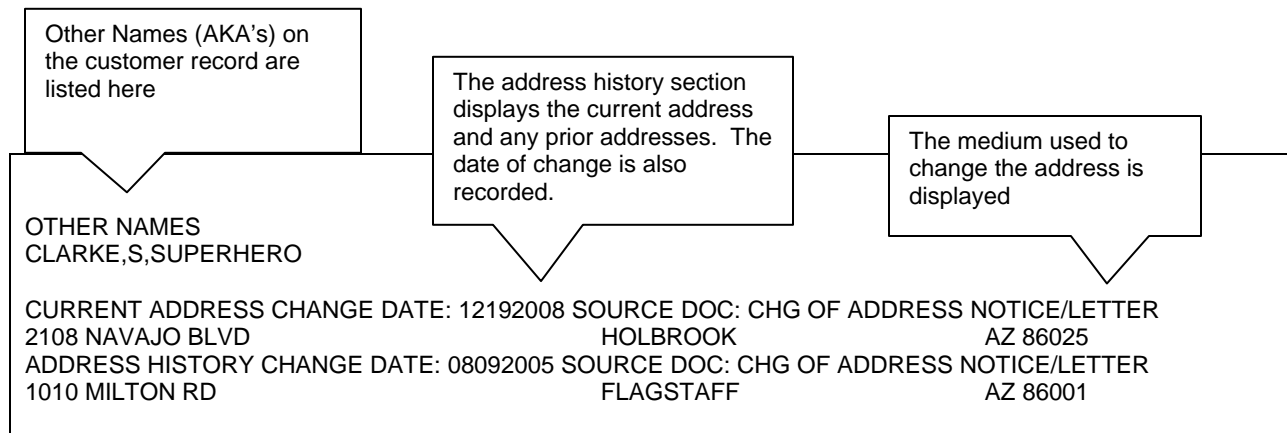
Section 3:

If there are no AKA's (also known as) on the record the "OTHER NAMES" field will not appear.

The address history section will also display any current mailing address and any mailing address history.

The "SOURCE DOC" (source document) field will display the medium used to change the address:

- Chg of Address Notice/Letter
- Service Arizona Transaction
- Application
- Telephone



Section 4:

A review of Section 4 will display all credentials of previously issued credentials and Section 2 of the MVR will identify the current credential held by the customer. The **issue date** of the credential **is the key**

- Section 4 will list any identification or permit credential that has been previously issued a one time to replace the credential showing on the base record (Section 2)
- If no expiration date, issue date or class of license display in Section 2 the individual may never have been issued a credential or may have an identification or permit credential only

Example: In Section 2 the record of Clarke Superhero displays a class “D” driver license issued 08092005 with an expiration date of 06102026. However Section 4 displays a class “I” Identification credential issued 03062007 with no expiration date. The Identification credential was issued after the driver license and is the most current credential. The driver license is no longer valid.

The heading “**NO ADDITIONAL PERMITS, AND/OR ID’S ON RECORD**” displays when there is no Identification or permit history.

Note: The heading “**ADDITIONAL LICENSES, PERMITS, AND/OR ID’S**” may appear instead of the heading “**IDENTIFICATION NUMBERS AND/OR PERMITS**” as shown above. **Both display the same information.**

Section 5:

Status Codes should also be reviewed to determine if the driver license is suspended or revoked. Restrictions and Endorsements are clearly displayed.

Previous Licenses are listed by class and state of issue. The issue date and expiration date of the credential are noted along with the license number.

Driver License Status Code Definitions:

- The actual status code number does not appear
- Most prohibitive status codes generate an entry on the MVR and clearly indicate weather the customer is **Suspended or Revoked** and if **Reinstatement Fees** are due
- **Not all status code definitions** attached to the base record **appear** on the MVR such as "Ignition Interlock Device Required" and "TTEAP – Prohibit Vehicle Registration Renewal"

Some common groupings of status code definitions found on MVR's:

Previous License Information is listed for the past ten years. The class of the credential and state of issue are indicated.

A ten year non-restricted MVR will display all prior license numbers including a social security number used as the driver license number.

Violation Codes fall into four different categories:

1. Actions

1. Actions: An Action may be MVD or Court directed.

Actions are the result of the steps taken by MVD or the Court in response to a specific violation (i.e. ARS 28-1382A - Extreme DUI may result in a DI ACTION, Suspension or Revocation)

It is the Action that Suspends, Revokes, Cancels or disqualifies an individuals driving privilege.

2. Arizona Revised Statute (ARS)

4. ACD Code

An ACD Code is used to record an out of state citation received by an Arizona resident. Universal ACD codes are used nation-wide to identify either the type of conviction or the reason for a withdrawal. The Description Field

This field displays the definition of the violation and other pertinent information. Now that we have acknowledged the fields, let's look at this MVR and figure out each of the fields.
