Working Day Standard Specification Definition Revised

Purpose

To emphasize that all construction contracts opening for bid after November 3, 2014 will reflect the revised Standard Specification 101.02 definition of a "Working Day". Also, in the interest of achieving consistency statewide, this bulletin provides guidance for determining whether a working day would be charged on a Saturday, Sunday or State-recognized holiday.

Background

The Department's Standard Specification 101.02 **Working Day** definition was revised July 14, 2014, as follows:

A day, exclusive of Saturdays, Sundays and State-recognized holidays, beginning at midnight, extending for a twenty-four hour period, and ending at midnight. Any Saturday, Sunday, or State-recognized holiday on which the contractor has been approved to work will also be counted as a working day. Working days on which weather conditions do not permit work on the project to proceed, as determined by the Engineer, will not be charged.

Guidance

Work on Saturdays, Sundays, or Holidays needs to be approved in advance. The only work the contractor can do without this approval is protecting the work already accomplished, providing dust control, or work of a similar nature. Several scenarios are provided in the table below to guide whether to charge a working day on a Saturday, Sunday or State-recognized holiday. These conditions assume there is no other work on-going.
